WHEREAS, recognition was granted to the institution, namely, Maharana Pratap Teacher Training College, 234 Behind Central Academy School, Dadabari, Chotta Choraha, Distt. Kota-324009, Rajasthan, vide Order No./F.NRC/NCTE/RJ 588/253<sup>rd</sup> Meeting (Part-2)/2016/151511-15 dated 24.06.2016 for conducting B.Ed. Course with an annual intake of 100 students.

AND WHEREAS, the institution submitted an application dated 27.04.2016 to the NRC-NCTE for shifting of premises from Maharana Pratap Teacher Training College, 234 Behind Central Academy School, Dadabari, Chotta Choraha, Distt. Kota-324009, Rajasthan to Maharana Pratap Teacher Training College, Khasra no. 377 & 374, Gram Moru Kala, Tehsil – Kanwas, Dist. Kota, Rajasthan.

AND WHEREAS, the case of the institution was considered by the NRC in its 242<sup>nd</sup> Meeting and the Committee decided to constitute a visiting team for conducting inspection so as to ascertain the preparedness for shifting of premises of the institution. The inspection of the institution was conducted on 23.09.2015.

AND WHEREAS, the matter was place before the NRC in its 253<sup>rd</sup> meeting (Part-2) held from June 10<sup>th</sup> – 14<sup>th</sup>, 2016 and it was decided that recognition granted to the institution for B.Ed. course be withdrawn under section 17 of the NCTE Act, 1993.

AND WHEREAS, the institution filed Writ Petition No. 9775/2016 in the Hon'ble High Court of Rajasthan at Jaipur Bench, Jaipur. The Hon'ble High court passed interim order dated 2.8.2016 and stayed the operation of impugned order of withdrawal issued by the NRC, NCTE vide order no. F. NRC/NCTE/RJ-588/253<sup>rd</sup> Meeting (Part-2) 2016/151511-15 dated 24.06.2016.

AND WHEREAS, the matter was again considered by the NRC in its 271<sup>st</sup> Meeting of NRC held from 07<sup>th</sup> to 09<sup>th</sup> June, 2017 in the light of the order dt. 27.4.2017 passed by the Hon'ble High Court of Judicature for Rajasthan at Jaipur Bench, Jaipur in S.B. Civil Writ Petition No. 9775/2016 and the Committee decided as follows:-

- As per the directions of the Hon'ble High Court, Rajasthan, Jaipur, recognition of institution is restored and the institution is permitted to shift from 234, Behind Central Academy School, Dadabari, Chotta Choraha, District-Kota, Pin Code- 324009 to Khasra No. 377 & 374 Gram Moru Kala, Tehsil- Kanwas, District- Kota.

AND NOW, therefore, the recognition of the institution, namely, Maharana Pratap Teacher Training College, 234 Behind Central Academy School, Dadabari, Chotta Choraha, Distt. Kota-324009, Rajasthan is hereby restored and is also permitted shifting of premises from 234 Behind Central Academy School, Dadabari, Chotta Choraha, Distt. Kota-324009 to Khasra no. 377 & 374, Gram Moru Kala, Tehsil – Kanwas, Dist. Kota, Rajasthan under clause 8(9) of the NCTE Regulations, 2014 for running B.Ed. programme of two-years duration.
