Sir,

The recognition for the B.Ed course was refused to the institution, namely, Maa Kali Bai Shikshan Sansthan, Plot / Khasra Number -851, Street / Road -0, Village - Kasampur, Post Office - Kasampur, Tehsil/Taluka- Kheragarh, Town/City- Kheragarh, District - Agra, State - Uttar Pradesh, Pin Code - 323121 vide order no. NRC/NCTE/NRCAPP-8039/243<sup>rd</sup> meeting/2015/125569-73 dt. 13.10.2015.

The institution filed an appeal against NRC order dt. 13.10.2015. The appellate authority passed an order dt. 28.03.2017.

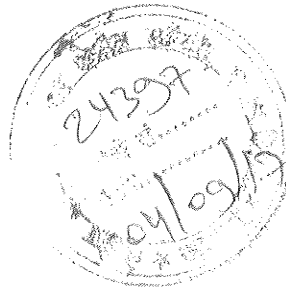
The matter was considered by NRC in its 270<sup>th</sup> meeting (Part-1) held on 29<sup>th</sup> to 30<sup>th</sup> May, 2017 and the Committee decided that in compliance of the order dated 28.03.2017 passed by the Appeal Committee, the entire case was re-visited and following observations were made:-

- The LOI was issued by NRC vide letter dated 16.05.2015. The reply of the same was not submitted by the institution.
- The SCN was issued to the institution on 17.08.2015. No reply was submitted by the institution to the SCN.
- NRC issued refusal order on 13.10.2015.
- Thereafter, the institution submitted the reply of LOI and misled the NRC as on the basis of the same, the institution was inadvertently issued recognition order.
- The correction of this order was issued by Corrigendum dated 24.05.2016, thereby deleting the name of institution from the recognition order dated 02.05.2016.
- Therefore, the earlier refusal order of NRC dt. 13.10.2015 stands.

In terms of above decision of NRC, the earlier refusal order dt. 13.10.2015 issued to Maa Kali Bai Shikshan Sansthan, Plot / Khasra Number -851, Street / Road -0, Village - Kasampur, Post Office - Kasampur, Tehsil/Taluka- Kheragarh, Town/City- Kheragarh, District - Agra, State - Uttar Pradesh, Pin Code - 323121 stands.
