REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, The Qaumi Taleemee Society, Street/Road- Paltan Bazar, Village/Town/City- Sultanpur, Post Office- Sultanpur, Tehsil/Taluka- Sadar, Town/City- Sultanpur, District:- Sultanpur, State- Uttar Pradesh had submitted an application i.e. NRCAPP-2332 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Moid Ahmad Prashikshan Sansthan, Plot Number/Khasara No.- 366, 373, 375, 374, 376, 377, 378, Street/Road- 0, Village/Town/City- Gorabarik, Post Office- Sultanpur, Tehsil/Taluka- Sadar, Town/City- Sultanpur, District:- Sultanpur, State- Uttar Pradesh for B.T.C. course on 03.10.2011.

AND WHEREAS, the matter was considered by NRC in its 248th Meeting held from 11th to 31st, January, 2016 and the Committee decided to issue Show Cause Notice on the following grounds: -

- The institution has not submitted reply of show cause notice dated 30.03.2012.

Accordingly Show Cause Notice was issued on 08.09.2016 to the institution.

AND WHEREAS, the institution has submit reply of Show Cause Notice on dated 21.09.2016. The matter was considered by NRC in its 261st Meeting held from 14th to 19th December, 2016 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -

- The applicant intuition has not submitted the reply of the show cause notice within the stipulated time.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Moid Ahmad Prashikshan Sansthan, Plot Number/Khasara No.- 366, 373, 375, 374, 376, 377, 378, Street/Road- 0, Village/Town/City- Gorabarik, Post Office- Sultanpur, Tehsil/Taluka- Sadar, Town/City- Sultanpur, District:- Sultanpur, State- Uttar Pradesh and recognition/permission is refused on the grounds mentioned above.

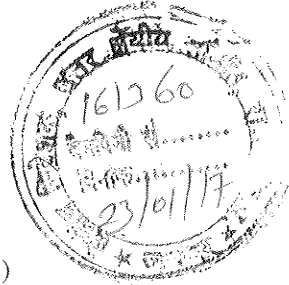
