REFUSAL/REJECTION ORDER

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Gonard Kalyan Vahini Samiti, Plot Number/Khasara No.- 0, Street/Road- 0, Village/Town/City- Nawabganj, Post Office- Nawabganj, Tehsil/Taluka- Tarabganj, Town/City- Nawabganj, District:- Gonda, State- Uttar Pradesh, Pin Code- 271303 had submitted an application i.e. NRCAPP-7219 to the Northern Regional Committee of NCTE for grant of recognition/permission to the institution i.e. Shivalik Mahavidyalaya, Plot Number/Khasara No.- 150Min, Street/Road- 0, Village/Town/City- Patna Khargaura, Post Office- Bhinga, Tehsil/Taluka- Bhinga, Town/City- Bhinga, District:- Shravasti, State- Uttar Pradesh, Pin Code- 271831 for B.Ed. course on 30.12.2012.

AND WHEREAS, the matter was considered by NRC in its 244th Meeting held from 30th to 31st October, 2015 and the Committee decided to issue Show Cause Notice on the following grounds: -

- The institution has not submitted reply of Letter of Intent issued by NRC, NCTE under clause 7(13) of NCTE Regulation, 2014.

Accordingly Show Cause Notice was issued on 19.11.2015 to the institution.

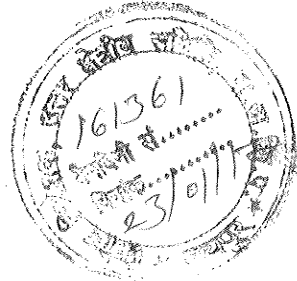
AND WHEREAS, the institution did not submit reply of Show Cause Notice. The matter was considered by NRC in its 261st Meeting held from 14th to 19th December, 2016 and the Committee decided that the application of the institution for grant of recognition/permission is refused on the following grounds: -


- The institution has not submitted the reply of show cause notice dated 07.09.2016 issued by the NRC, NCTE in stipulated time period.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby rejects the said application of the institution i.e. Shivalik Mahavidyalaya, Plot Number/Khasara No.- 150Min, Street/Road- 0, Village/Town/City- Patna Khargaura, Post Office- Bhinga, Tehsil/Taluka- Bhinga, Town/City- Bhinga, District:- Shravasti, State- Uttar Pradesh, Pin Code- 271831 and recognition/permission is refused on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under Sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines of appeal may be seen on NCTE Website.
