Rejection Order

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993, **Krishan Education And Welfare Society, Plot No.-4, Street/Road-Mahra Road, Village/Town/city/Post office-Hullahedi, Tehsil/Taluka-Sonepat, District-Sonepat-131001, Haryana** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. **Bijender Singh, Plot No.-4, Street/Road-Mahra Road, Village/Town/city/Post office-Hullahedi, Tehsil/Taluka-Sonepat, District-Sonepat-131001, Haryana** for B.Ed. course in the office of NRC on 28.12.2013.

AND WHEREAS, the file was considered by the NRC in its 219th meeting held from 26th to 29th September, 2013 and the NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution.

- **The Society/Institution has submitted land document which is Neither in the name of the Society or Institution. Thus, the institution has not submitted the land document as required under Provision of clause 8 (7) of NCTE Regulations, 2009.**

AND WHEREAS, a letter dated NIL received from the institution in NRC office on 16.12.2013 regarding refund of FDR, Endowment and etc. The matter was considered by the NRC in its 222th meeting held from 24th to 28th December, 2013 and NRC decided that the application for the said course be rejected under provision of NCTE, Regulations, 2009 on the followings points:-

- **Request of the institution for withdrawal of application for the proposed course is accepted. File be closed and FDRs if any be returned to the institution.**

NOW THEREFORE, in exercise of the powers vested under section 14/15(3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. **Bijender Singh, Plot No.-4, Street/Road-Mahra Road, Village/Town/city/Post office-Hullahedi, Tehsil/Taluka-Sonepat, District-Sonepat-131001, Haryana** for B.Ed. course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
