Rejection Order

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Babulal Singh Memorial Shakshik Evam Dharmarth Trust, Plot No. – 693,717, Street/ Road – Chanaita Road, Village/Town/City- Atarauliya, Post Office – Atarauliya, Tehsil – Budhanpur, Dist. – Azamgarh, UP- 223223 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Thakur Jagdish Prasad Singh Mahavidyalay, Plot Number – 693&617, Village – Atarauliya(Purwa), Post Office – Atarauliya, Tehsil/Taluka – Budhanpur, Dist. – Azamgarh, UP- 223223 for B.Ed. Course of one year duration for an intake of 100 seats students on 26.12.2012.

The case of the institution was considered by NRC in its 219th Meeting and as per decision taken by NRC in its 219th Meeting, Show cause Notice dated 22.10.2013 was issued to the institution on the following points:-

- The institution has not submitted documents for removal of deficiencies in their reply.

AND WHEREAS, the institution has submitted the reply of Show Cause Notice 28.11.2013. The matter was considered by NRC in its 222th Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has not submitted reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. Thakur Jagdish Prasad Singh Mahavidyalay, Plot Number – 693&617, Village – Atarauliya(Purwa), Post Office – Atarauliya, Tehsil/Taluka – Budhanpur, Dist. – Azamgarh, UP- 223223 for 100 seats in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The following FDRs are returned herewith in original.
