Rejection Order

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, 1993 Shri Rameshwar Dayal Sarva Samaj Seva Samiti, Plot No. - NA, Village - Orai, Post Office - Orai, Tehsil - Orai, Dist. - Orai, UP had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Shree Rameshwar Dayal Mahavidyalaya, Orai, Jalaun, Plot No. - NA, Village - Orai, Post Office - Orai, Tehsil - Orai, Dist. - Orai, UP for B.Ed. Course of One years duration for an intake of 50 seats students on 31.01.2013.

The case of the institution was considered by NRC in its 217th Meeting and as per decision taken by NRC in its 217th Meeting, Show cause Notice dated 08.08.2013 was issued to the institution on the following points:-

- The Society/institution has not submitted land document in favour of the Society/institution. Certified copy of registered land document (office of Registrar/Sub Registrar) as required under provisions of NCTE Regulations, 2009 has not been submitted.

AND WHEREAS, the institution has not submitted the reply of Show Cause Notice. The matter was considered by NRC in its 221th Meeting and it was decided that the application of the institution be rejected on the following grounds:

- The institution has not submitted reply of SCN issued to the institution by NRC.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3)(b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. Shree Rameshwar Dayal Mahavidyalaya, Orai, Jalaun, Plot No. - NA, Village - Orai, Post Office - Orai, Tehsil - Orai, Dist. - Orai, UP for 100 seats in the B.Ed. course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of this order. The following FDRs are returned herewith in original.
