Rejection Order

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Shiv Shakti Educational Society, Plot No.- 1933 dnb, Street/Road- 9 ward no.- 21, Village/Town/City/P.O- Barnala, Tehsil/Taluka/Town/City- Barnala, District- Sangrur- 148101, State- Punjab had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Shiv Shakti College of Education, Plot No.- 87/22m(4-0)23m(2-0)24m(2-0), Village/P.O/Tehsil/Taluka/Town/City- Barnala, District- Sangrur- 148101, State- Punjab for B.Ed. Course in the office of NRC on 31.12.2012.

AND WHEREAS, the matter was considered by the NRC in its 217th meeting held from 26th to 29th July, 2013 and NRC decided to issue show cause notice. Accordingly, Show Cause Notice was issued to the institution on 07.08.2013 on the following points :-

- *The institution has not submitted copy of the land documents as required in NCTE Regulations, 2009.*

AND WHEREAS, a letter dated 01.09.2013 received from the institution in response to the 7 (1) notice received in NRC office on dated 12.09.10.2013. The matter was considered by the NRC in its 222th meeting held from 24th to 28th December, 2013 and NRC decided that the application for the said course be withdrawal under provision of NCTE, Regulations, 2009 on the followings points:-

- *Request of the institution for withdrawal of application for the proposed course is accepted. File be closed and FDRs if any be returned to the institution.*

NOW THEREFORE, in exercise of the powers vested under section 14/15(3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. Shiv Shakti College of Education, Plot No.- 87/22m(4-0)23m(2-0)24m(2-0), Village/P.O/Tehsil/Taluka/Town/City- Barnala, District- Sangrur- 148101, State- Punjab for B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte-india.org within 60 days from the issue of this order.
