**Rejection Order**

WHEREAS, in terms of section 14(1) of the NCTE Act, 1993 Krishna Education And Welfare Society, Plot No.- 04, Village/Town/City- Hullahedi, Post Office- Hullahedi, Tehsil/Taluka- Sonapat, Dist.- Sonapat, State- Haryana- 131001 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Krishna Institute Of Education Research & Technology (Taken from B.U.C. Submitted by institute), Plot No.- 04 (Khasra no.- 33), Village- Hullahedi, Post Office- Hullahedi, Tehsil/Taluka- Sonapat, Dist.- Sonapat, State- Haryana- 131001 for D.El.Ed. Course in the office of NRC on 31.01.2013.

AND WHEREAS, the deficiency letter was issued to the institution on 13.08.2013 of the following point:-

- Certified copy of registered land documents issued by the competent authority (Office of Registrar/ Sub Registrar) as required under provision of NCTE Regulations, 2009 has not submitted.
- A Copy of approved Building plan having demarcated built-up area for proposed D.El.Ed. Course, existing course and other educational courses being conducted by institution at khasra no. / Plot no. 04 is required to be submitted.
- Notarized change of land use (CLU) certificate issued by SDM under relevant section prevailing land Act of Haryana State.
- Name of institution has not been mentioned in online application form.
- Institution is required to submit a copy of certificate issued by National Commission for Minority Educational Institutions granting minority status to proposed D.El.Ed course.
- The institution is required to submit an Affidavit of Rs. 100/- stamp paper as per the format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (ii) of the NCTE Regulations 2009 & page 4 & 5 of the Online Application form.

AND WHEREAS, a letter received from the institution in NRC office on dated 16.12.2013. The matter was considered by the NRC in its 222<sup>th</sup> meeting held from 24<sup>th</sup> to 28<sup>th</sup> December, 2013 and NRC decided that the application for the said course be withdrawal under provision of NCTE, Regulations, 2009 on the followings points:-

- Request of the institution for withdrawal of application for the proposed course is accepted. File be closed and FDRs if any be returned to the institution.

NOW THEREFORE, in exercise of the powers vested under section 14/15(3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby reject the above application of the institution i.e. Krishna Institute Of Education Research & Technology (Taken from B.U.C. Submitted by institute), Plot No.- 04 (Khasra no.- 33), Village- Hullahedi, Post Office- Hullahedi, Tehsil/Taluka- Sonapat, Dist.- Sonapat, State- Haryana- 131001 for D.El.Ed. Course on the grounds mentioned above.

If the institution is not satisfied by the above order they can prefer an appeal to the Council (NCTE, New Delhi) in terms of sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte-india.org](http://www.ncte-india.org) within 60 days from the issue of this order.
