
Sub: - Show Cause Notice under section 14 (3) (b) of the NCTE Act: Notice as per 221<sup>th</sup> NRC meeting decision.

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 221<sup>th</sup> meeting considered the case of your institution namely **Eshan College of Education, Plot No. - 31, 32, 33, Street No. 28, KM MILE, Village - Shahzadpur Pauri, Post Office - Farah, Tehsil - Mathura, Dist. - Mathura, UP 281122** for the proposed course **B.Ed.** along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-
