Sub: - Show Cause Notice under section 14/15 (3) (b) of the NCTE Act: Notice as per 221th NRC meeting decision

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 221th meeting considered the case of your institution namely **DIRD College of Education, Plot No. - 247, 79, Street No. - DIRD, Village - Holambi Khurd, Post Office - Holambi Kalan, Tehsil/Taluka - Alipur, Town/City - Delhi, State - DL, District - North West Delhi (DL), Pin Code - 110011** for the proposed course **B.Ed.** along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-Hqrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

- *The institution has submitted two applications ID No. NRCAPP-5466 & NRCAPP-2192, the name and address of these institutions are same. As per provisions of clause 8(2) of NCTE Regulation, 2009, in the first instance an institution shall be considered to grant of recognition of only one course for a basic unit as prescribed in the norms and standards for the particular teacher programme. Therefore, more than one application submitted by the institution cannot be considered at the same time.*
- 2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.
- 3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
- 4. The NRC further decided that the decision concerning the applications of the institution already taken, if any be also kept in abeyance till reply of the show cause notice is received from the concerned institution and considered by the NRC.
