The Northern Regional Committee, National Council for Teacher Education in its 221th meeting considered the case of your institution namely **Rama Devi Kanya Mahavidyalaya, Plot No.- E-3D(Sector- 61,Noida), Village- N.A., Post Office- Sector-34 Noida, Tehsil/Taluka- Dadri, Dist.- Gautam Buddha Nagar, Uttar Pradesh- 201307** for additional intake in B.Ed. course along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

1. The request of the institution to change the course is not acceptable.
2. Reply of DLI letter not submitted by the institution.

2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.

3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3) (b) of the NCTE Act, 1993 as it deems fit and proper.
