Sub:- Notice under section 14/15 of the NCTE Act: Notice as per 224<sup>th</sup> NRC meeting decision

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 224<sup>th</sup> meeting held from 28<sup>th</sup> January to 02<sup>nd</sup> February, 2014 considered the case of your institution namely R K Memorial College of Education, Plot No. 194, Khasara No. 194, Street Number- 1, Vill.- Pardhana, Po. off- Pardhana, Tehsil- Israna, Town- Panipat, State- HR, District- Panipat, Pin Code -132103 for the proposed or existing course B.Ed. alongwith original file of the institution, reply submitted by the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

“The original file of the Institution and alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- The institution has applied for D.El.Ed. course, hence Minority Certificate issued by Competent Authority under clause 30(12) of the constitution of India to declared the institution as Minority Institute is required to be submitted.
- The reply of the deficiency letter dated 05.08.2013 has not been submitted till date.
- Letter from DGHE, Haryana received (13.09.2013 in NRC) has informed, the NRC that the application of R.K. Memorial College of Education, Village - Pardhana, District - panipat for seeking recognition of B.Ed. course from the college be not entertained..

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
