Sir,

The court order dt. 29.05.2014 passed by the Hon'ble High Court of Punjab and Haryana at Chandigarh in the writ petition (Civil) no. 10935 of 2014 was considered by NRC in its emergent meeting held from 10<sup>th</sup> and 11<sup>th</sup> June, 2014 and the committee decided the following: -

The original file of the Institution and reply of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observations was made:-

- (i) On perusal of the reply dated 1.3.2014 of Show Cause Notice submitted by the institution and after examination the Committee found that the Jamabandi reveals that the land is mortgaged with the PNB, hence the institution is required submit the non encumbrance certificate in respect of land possessed by it.
- (ii) On further perusal of the Jamabandi, the Committee noted that the same is silent about use of the land occupied by the institution.

Therefore, the institution is required to submit a fresh Jamabandi showing the land is free from all encumbrances and CLU for educational purposes and also submit a Non-encumbrance certificate and land use certificate.

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision as per the provisions of the NCTE Act, 1993, Rules & Regulations, as it deems fit and proper.
