The Northern Regional Committee, National Council for Teacher Education in its 238th meeting (Part-VI) held from May 20th to 31st, 2015 considered the case of your institution namely, Mai Bhago College of Education Pididi, Plot No.-NA, Street No.- NA, Village- Pididi, P.O.- Tarn Taran, Tehsil/Taluka – Tarn Taran, Town/City – Tarn Taran, District – Tarn Taran, State – Punjab-143401. for the proposed B.Ed. Course alongwith original file of the institution, viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-HQrs. The NRC after considering the matter in detail observed/decided the following:

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observation was made:-

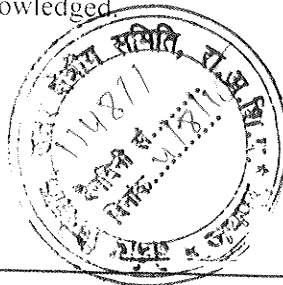
- The institution neither replied to letter no. 55569 dated 25.07.2013 nor to the letter of NRC no. 81413 dated 09.01.2015. Why the application be not rejected.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.”

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the Management as per provisions of the NCTE Act, Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
