Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 239th meeting considered the case of your institution namely, SDRBL Sheela Devi Ram Bharose Lal Mahavidyalaya, Plot No. - 24&25S, Village - Aronj, Post Office - Shikohabad, Tehsil /Taluka - Shikohabad, Dist. - Firozabad, UP -205135, for the proposed course B.Ed. along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

"The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made,

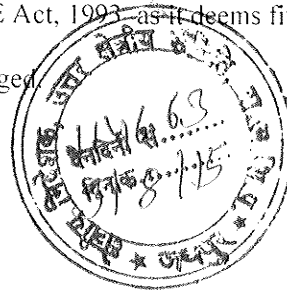
- The original building completion certificate in the prescribed proforma has not been submitted.
- The institution to submit unedited CD of the inspection by the VT done on 09.11.2013.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice."



3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
