The Northern Regional Committee, National Council for Teacher Education in its 240th Meeting held from July 20th to 22nd, 2015 considered the case of your institution namely Lalita Devi College of Higher Education, Plot No.-136, Street No.-02, Village/Post Office- Usri Khurd, Tehsil/Taluka- Rudrapur, Town/City-Gauri Bazar, District- Deoria, State- Uttar Pradesh-274202. for the proposed B.Ed. course alongwith original file of the institution, viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-HQrs. The NRC after considering the matter in detail observed/decided the following: -

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations were carefully considered by NRC and following observation was made.

- As per Regulations, 2014, institution has not submitted faculty in Physical Education & Fine Arts.

Hence, show cause notice under Section 14/15 (3) (b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice..

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
