- In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.
- Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
