- As per Regulations, 2014, institution has not submitted faculty in Physical Education & Fine Arts.

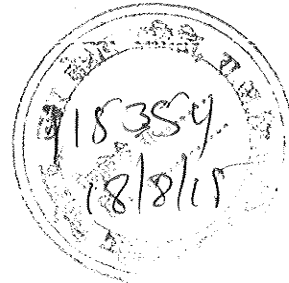


