Sub:- Show Cause Notice on the points of deficiency

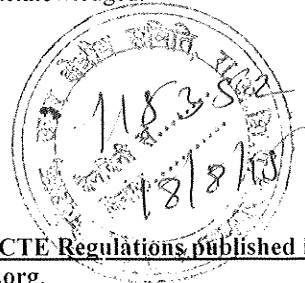

Sir/Madam,

With reference to your application submitted for recognition for the D.E.C.Ed. Course in the office of NRC, it is to inform you that the matter was considered by NRC in its 224<sup>th</sup> Meeting and it was decided that the application be processed and deficiencies to be communicated to the institution. The said application has been processed by NRC, NCTE, Jaipur as per provisions contained in the NCTE Regulations, 2014. It is informed that on preliminary perusal of the documents submitted with your application viz.-a-viz. provisions of NCTE Regulations, 2014, your application is found deficient on the following points which are as under:

- o Fixed deposit receipt of Rs. Five Lakhs in original submitted by the institute are not form Nationalize Bank.
  - o Fixed deposit receipt of Rs. Three Lakhs in original submitted by the institute are not form Nationalize Bank.
  - o Notarized copy of change of land use certificate issued under clause 143 of Up land Act by the competent authority has not submitted.
  - o Certified copy of registered land documents issued by the competent authority (office of Registrar/Sub-Registrar) as required under provision of NCTE regulations, 2009 has not submitted.
  - o The building plan submitted by the institution approved by Gram Pradhan does not indicate Khasra No./Plot No. & Land
  - o The institution is required to submit NOC from Affiliating Body.
  - o The institution is required to submitted the evidence to establish that the institution is a composite institution.
5. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30days.
  6. Your written representation along with an affidavit must reach this office within 30days of the issue of this notice. In the event of this office not receiving any representation within 30days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
