Sub.: Show Cause Notice before summarily rejection under clause 7(1) of NCTE Regulation, 2009-reg.



Sir/ Madam,

This has reference to the subject cited above, institution has submitted an application in online mode on 29.12.2012 and physical application has been received in the office of NRC on 03.01.2013 for D.El.Ed. course in the proposed institution i.e. Kamaksha Prasad Pratap Narayan Mishra College of Education And Technology, Plot / Khasra Number- 706, Street Number-00, Village- Bhojpur, Post Office- Ramganj, Tehsil/Taluka- Lalganj Ajhara, Town/City- Ramganj, District- Pratapgarh(UP), State - Uttar Pradesh, Pin Code -000000. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

- As per certified copy of land documents submitted with the application the land is in the name of Dr. Hari Prasad Mishra S/O Late Pratap Narayan Mishra Presedent through Late Pratap Narayan Mishra Gram Vikas Sansthan which is not acceptable as per clause 8 (7) (i) of NCTE Regulation 2009. However, the institution has submitted Khatouni in which the land is in the name of institution.
- 2. The matter was considered by NRC in its 214th Meeting and it was decided that a Show Cause Notice be issued to the Institution before summarily rejection of said application on the following grounds:
 - As per certified copy of land documents submitted with the application the land is in the name of Dr. Hari Prasad Mishra S/O Late Pratap Narayan Mishra Presedent through Late Pratap Narayan Mishra Gram Vikas Sansthan which is not acceptable as per clause 8 (7) (i) of NCTE Regulation 2009.
- 3. In view of the above, you are hereby requested to submit the representation of the institution on the above observation(s) within 30 days from the date of issue of notice.
- 4. Your written representation must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within stipulated period, it will be presumed that you do not wish to make any representation, and the NRC shall take the decision, as it deems fit and proper.
