REFUSAL ORDER

Date: 17 AUG 2015

WHEREAS, in terms of section 14/15(3)(b) of the NCTE Act, Shree Ganpati Charitable & Welfare Trust, Plot Number- B-118, Street/Road- Garh Road, Village/Town/City- Takshila Colony, Post Office- Medical College, Tehsil/Taluka- Meerut, Town/City- Meerut, District- Meerut (UP), State- Uttar Pradesh, Pin Code- 250004 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking permission to the institution i.e. Laxmi Bai Girls Education College, Plot/Khasra Number- 264,260, Street Number- NH-24, Village- Khungawali, Post Office- Gajraula, Tehsil/Taluka- Hasanapur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- Uttar Pradesh, Pin Code- 244235 for B.Ed. Course of one year for an intake of 100 seats students on 31.12.2012.

AND WHEREAS, As per decision of NRC taken in its 236<sup>th</sup> meeting, Show Cause Notice was issued to the institution on 14.05.2015 on the following grounds:

- Original FDRs of Rs. 5 lakhs towards Endowment Fund and Rs. 3 lakhs towards Reserved Fund in original Fund in original from Nationalized bank has not submitted.
- The institution has not submitted approved building plan in original. The original building plan approved by competent authority indicating name of institution, name of the course, Khasra / plot no. of land, total land area & built up area. Size of multipurpose hall, classrooms, library, different resource centre etc. as per NCTE norms for the proposed course is required to be submitted.
- The name of the application Society / Trust is Shri Ganpati Charitable & Welfare Trust where as the land is in favour of Ganpati Charitable & Welfare Trust which is not as per clause 8(7)(i) of NCTE Regulation, 2009.
- The institution has submitted another application NRCAPP-8808 and NRCAPP-8833 which is against as per Clause 8(2)(3) of Regulation 2009.
- The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hence the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

AND WHEREAS, The institution has not submitted its reply of the Show Cause Notice. The matter was considered by NRC in its 241<sup>st</sup> Meeting held on 03<sup>rd</sup> to 07<sup>th</sup> August, 2015 and it was decided that the application of the institution be refused on the following grounds:


- Institution has not submitted reply of Show Cause Notice.

NOW THEREFORE, in exercise of the powers vested under section 14 (3) (b) of NCTE Act, 1993, the Northern Regional Committee hereby refuse the recognition sought by the institution i.e. Laxmi Bai Girls Education College, Plot/Khasra Number- 264,260, Street Number- NH-24, Village- Khungawali, Post Office- Gajraula, Tehsil/Taluka- Hasanapur, Town/City- Gajraula, District- Jyotiba Phule Nagar (UP), State- Uttar Pradesh, Pin Code- 244235 for the B.Ed. Course on the grounds mentioned above.

If the institution is not satisfied with order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website [www.ncte.india.org](http://www.ncte.india.org) within 60 days from the date of this order. The guidelines of appeal are enclosed herewith.

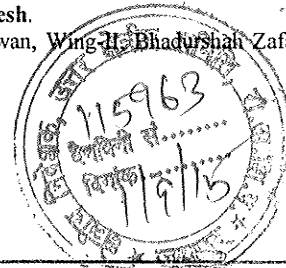
