Sub:- Show Cause Notice under section 14/15 (3) (b) of the NCTE Act: Notice as per 241st Meeting NRC NCTE decision.
(Code No. NRCAPP-3704)

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 241st Meeting held from 03rd to 07th August, 2015 considered the case of your institution namely, Aakash College of Education, Plot No.- 225, Village- VPO. Kalirawan, Post office- Kalirawan, Tehsil/Taluka- Mandi Adampur, Distt.- Hissar, Haryana-125052 for the proposed D.El.Ed. (Increase in Intake) course alongwith original file of the institution, viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs.

The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision "the institution is required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 including the following" :-

- A proof/evidence to the effect that it is a composite institution as per provisions of the NCTE Regulations, 2014
- In case the institutions which are not composite at present shall ensure that they have become composite institutions before commencement of the academic session 2016-17. An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE.
- No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014.

In addition to the above, you are also requested to submit the following documents/clarifications:-

- The institution has submitted DD of Rs. 50,000/- dated 26.05.2015 which is out dated. Hence, the institute is required to submit renew the DD of 1,50,000/- at the earlier. (Original DD of Rs. 50,000/- is enclosed)
- The institution has not submitted a copy of the order/letter containing permission of the competent authority to use the land for educational purposes as per clause 8(5) of the NCTE Regulations, 2014. (In case the land falls under the jurisdiction of urban area/controlled area, the permission of District Town Planner is required. In case the land falls under the rural area, the permission of concerned ADM/SDM/DM or other competent authority to use the land for educational purposes under the provisions of the State Law is required to be submitted).
- Non Encumbrance Certificate as required under clause 8(4) (i) of the NCTE Regulations, 2014 not submitted.
- Certified copy of land documents of sub Registrar from Revenue Department is required.
- The copy of approved building plan indicating name of institution, name of course, khasra no./plot no. of land, total land area and earmarked built up area, size of multipurpose hall and class rooms etc. for the proposed course is required to be submitted.

2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 30 days.

3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.

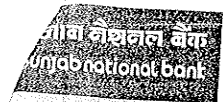

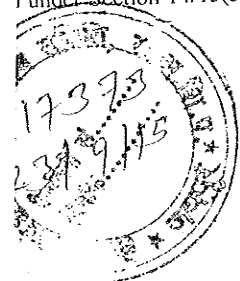
