Sub:- Notice under section 14 (3) (b) of the NCTE Act, 1993: Notice as per 242nd NRC Meeting decision

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 242nd Meeting held from 01st to 03rd September, 2015 considered the case of your institution namely Mangal Jyoti Sansthan, Plot No. 432 and 433, Village-Nanthera Anantpur, Post office-Bhagwanpur, Tehsil/Taluka-Roorkee, Town/City-Roorkee, District-Haridwar-24667, State-Uttarkhand for the proposed D.El.Ed. course alongwith original file of the institution, viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-HQrs. The NRC after considering the matter in detail observed/decided the following: -

The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC and following observation was made:

- *The institution has not submitted approval of the staff from the affiliating body*

In addition to above the institution shall be required to submit the following documents:-

- A proof/evidence to the effect that it is a composite institution as per provisions of the NCTE Regulations, 2014*
- In case the institutions which are not composite at present shall ensure that they have become composite institutions before commencement of the academic session 2016-17. An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE.*
- No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014.*


Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
