Sub:- Notice under section 14 (3) (b) of the NCTE Act: Notice as per 217<sup>th</sup> NRC meeting decision

Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 217<sup>th</sup> meeting held from 26<sup>th</sup> to 29<sup>th</sup> July, 2013 considered the case of your institution namely St. Paul College of Education Rohtak, Plot/Khasara No. – 51/14, Street No. – NA, Village – Para, Post office – Rohtak, Tehsil/Taluka/Town/City – Rohtak, Distt. – Rohtak (HR) – 124001, State - Haryana for the proposed B.Ed. Course alongwith original file of the institution, reply submitted by the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. The NRC after considering the matter in detail observed/decided the following: -

The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:

- As per V.T. Report, there is a difference in the measurement of the class rooms and multipurpose hall. Area of the multipurpose hall in the building plan is 2555.80 Sq. ft. but on physical verification V.T found that the actual area of the multipurpose hall is 1332.00 Sq.ft. and the area of the class room is 432.00 Sq. ft. but as per building plan, it is 648 Sq. ft.. Institution is misleading the NRC.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 30 days.

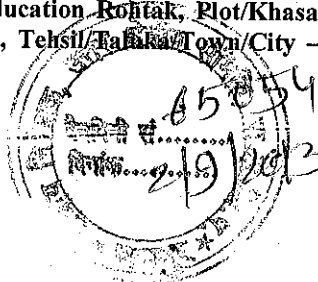
