Sub:- Show Cause Notice under section 14 (3) (b) of the NCTE Act: Notice as per 217th NRC meeting decision

Sir/Madam,

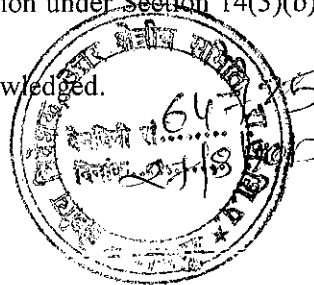
The Northern Regional Committee, National Council for Teacher Education in its 217th meeting considered the case of your institution namely **SRR Education And Research College, Mathura, U.P.** for the proposed course **B.Ed.(Co.Ed)** along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

- i. *The Society/institution has submitted private lease deed for 30 years between Manoj Kumar s/o Shri Hari Singh and S.R.R. Education and Research college.*
- ii. *As per clause 8(7)(i), of the NCTE Regulations, 2009, No institution shall be granted recognition under these Regulations unless the institution or society sponsoring the institution is in possession of required land on the date of the application.*
- iii. *As per clause 8(7)(i), No. institution shall be granted recognition under these Regulations unless the institution or society sponsoring the institution is in possession of required land on the date of the application. The land free from all encumbrances could be either on ownership basis or on lease from Government or Government institution for a period of not less than 30 years. In cases where under relevant state or Union Territory laws the maximum permissible lease period is less than 30 years, the State Government or Union Territory Administration law shall prevail. However, no building shall be taken on lease for running any teacher training course. Thus, the institution does not possess valid land on the date of application.*
- iv. *The society/institution has submitted private lease deed for 30 year between Manoj Kumar s/o Shri Hari Singh and S.R.R. Education and Research college. Which is not acceptable as per clause 8 (7) (i) of NCTE Regulations 2009.*


2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.

3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
