Sub: - Show Cause Notice under section 14/15 (3) (b) of the NCTE Act: Notice as per 242nd Meeting NRC Meeting decision.



The Northern Regional Committee, National Council for Teacher Education in its 242nd Meeting considered the case of your institution namely **Dr Rajendra Prasad Memorial Girls Degree College, Plot Number- 1365, 1366, Street/Road- Para Road, Village/Town/City- Para, Post Office- Raja Ji Puram, Tehsil/Taluka- Lucknow, Town/City- Lucknow, District- Lucknow, Pin Code- 226017, State- Uttar Pradesh** for the proposed course **D.E.C.Ed.** along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail decided that before taking final decision following documents/clarifications are required to be submitted by the institution:-

- The land is on private Lease basis which is not acceptable as per NCTE Regulations.
- In addition to above the institution shall be required to submit the following documents:-
 - A proof/evidence to the effect that it is a composite institution as per provisions of the NCTE Regulations, 2014.
 - In case the institutions which are not composite at present shall ensure that they have become composite institutions before commencement of the academic session 2016-17. An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE.
 - No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014.
2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.
3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
