**SHOW CAUSE NOTICE**


WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, Radhika Social Welfare and Educational Trust, Plot No.- 9, Village- Navalpur, Post office- Shivpur, Tehsil/Taluka- Sadar, Town/city- Varanasi, Distt.- Varanasi-221003, Uttar Pradesh. had submitted an application to the Northern Regional Committee of NCTE for grant of recognition to Ambition Institute of Teacher Education, Plot No.- 163, 168kh, 161169, 160kh, 165, Village- Murdaha, Post office- Murdaha, Tehsil/Taluka- Sadar, Town/city- Varanasi, Distt.- Varanasi-221202, Uttar Pradesh. for D.El.Ed. Course of Two years duration on 30.06.2015.

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 269<sup>th</sup> (Part-2) meeting held from 26<sup>th</sup> April to 02<sup>nd</sup> May 2017 considered the case of the institution under provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. and decided as under: -

- The institution has not submitted the approved Building plan signed by the Competent Govt. Authority indicating the name of the course, name of the institution, Khasra No./Plot No., total land area, total built-up area and the measurements of the Multi-purpose Hall as well as the other infrastructural facilities such as class rooms etc.
- The institution has not submitted the Land Use Certificate issued by the Competent Authority to use the land for educational purpose.
- The institution has not submitted the Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances.

NOW THEREFORE, the institution is required to submit the representation /compliance accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations. The representation along with an affidavit must reach this office within 30 days of the issue of this notice. In case the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take as per provisions of the NCTE Act, 1993 and regulations.
