SHOW CAUSE NOTICE

WHEREAS, in terms of section 14/15 of the NCTE Act, 1993 the Shyam Lal Panwar Anandi Devi Memoria Cheritable Trust, Plot No-S P 2&3, Street/Road-NH-8, Village/Town/City-Kant kalwar, Post office-Achrol, Tehsil/Taluka-Amber, Town/City-Jaipur, District-Jaipur, State-Rajasthan, Pin Code-303002 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking recognition/permission to the institution i.e. MJRP College of Education, Plot No- S P 2&3, Street Number-NH-8, Village-Kant Kalwar, Post Office-Achrol, Tehsil/Taluka-Amber, Town/City-Jaipur, District-Jaipur, State-Rajasthan, Pin Code-303002 for B.Ed., M.Ed. Course on 09.07.2015.


AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 252nd (Part-4) meeting held from 19th April to 02nd May, 2016 considered the case of the institution under provisions of the NCTE Act. Rules. Regulations and guidelines issued by NCTE-Hqrs. and decided as under:

- The institution/university did not submit the certificate of accreditation of NAAC which is required under NCTE Regulations, 2014.
- The institution/university did not submit the proof of having residential accommodation which is required under NCTE Regulations, 2014.
- The institution/university did not submit proof of running B.Ed. and M.Ed. programmes since last 5 years which is required under NCTE Regulations, 2014.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

NOW THEREFORE, the institution is required to submit the representation /compliance accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations. The representation along with an affidavit must reach this office within 30 days of the issue of this notice. In case the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take as per provisions of the NCTE Act, 1993 and regulations.

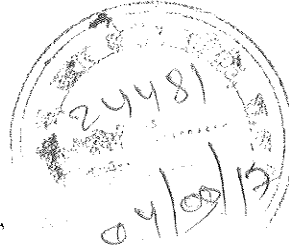
