SHOW CAUSE NOTICE

WHEREAS, in terms of Section 14/15(3)(b) of the NCTE Act, 1993, **Muj Jain Memorial Educational Trust, P.No.-906/9, Street/Road-Kewat Ganj Near Babra Mohalla, Village/Town/City-rohtak, Post office-rohtak, Tehsil-Rohtak, State-Haryana, Pin code-124001** had submitted an application to the Northern Regional Committee of NCTE for grant of recognition to **Muj Jain College of Education, P.No.-42/20(7.12), 21(6.15), 52/4, Village-Chander Kalan, Post office-Chader Kalan, Tehsil/Taluka-Tohana, District-Fatehabad, State-Haryana, Pin code-125120, for D.El.Ed. (Add.) Course of two years duration on 18.02.2012.**

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 273rd meeting held from 26th to 27th July, 2017 considered the case of the institution under provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. and decided as under: -

In compliance with the Order dated 24.6.2017 of the Appeal Committee, NCTE (HQ), New Delhi, the Committee considered the Memo No. SCERT/Science/2017/233 dated 08.6.2017 issued by the Director, SCERT, Gurugram (Haryana) and the following observations were made:-

- The list of the teachers verified by the letter dated 08.06.2017 of the SCERT, Gurugram, Haryana contains hand written word 'LEFT' in front of several teachers.
- The Management of the institution is required to submit the details of faculty presently working in the institution for the existing basic unit of D.El.Ed. and the proposed additional intake of the D.El.Ed. course, on Rs. 100/- non-judicial stamp paper in the prescribed format along with the approval of the SCERT.
- The institution has not submitted the Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances.

Hence, show cause notice under Section 14/15 (3)(b) of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

NOW THEREFORE, the institution is required to submit the representation /compliance accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations. The representation along with an affidavit must reach this office within 30 days of the issue of this notice. In case the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take as per provisions of the NCTE Act, 1993 and regulations.

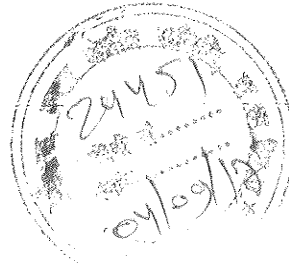
