AND WHEREAS, the institution submitted an application dated 30.06.2017 for Shifting of Premises of Oxford International College of Education, V.P.O - Asrawan, Tehsil/Taluka - Adampur, Distt.-Hisar, State-

AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 270th meeting held from 29th to 30th May, 2017 considered the case of the institution under provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. and decided as under: -

- The details of Teaching & Non-teaching staff have not been provided to the VT members.
- Curriculum laboratory needs to be strengthened.
- Computer Lab needs to be improved.
- Records have not been shown to the VT members whether salaries are being paid through cheque/account transfer.
- Website is not found updated as per NCTE Regulations, 2014.
- Building Plan & BCC are not found in Order.
- Purchase related bills & Vouchers are not provided to VT members for verification.
- The Records relating to Finances & Accounts have not been provided for verification.
- Staff lists for B.Ed. & D.El.Ed. duly approved by the affiliating body are not submitted.

Hence, show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

NOW THEREFORE, the institution is required to submit the representation /compliance accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations. The representation along with an affidavit must reach this office within 30 days of the issue of this notice. In case the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take as per provisions of the NCTE Act, 1993 and regulations.
