SHOW CAUSE NOTICE

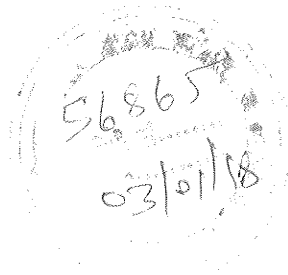


