SHOW CAUSE NOTICE

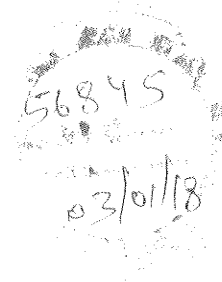
