SHOW CAUSE NOTICE

WHEREAS, in terms of section 14/15 of the NCTE Act, 1993 the Educational Culture Society, 3/571, Pradhan Marg, Malviya Nagar, Jaipur -302017, had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking recognition/permission to the institution i.e. Ujas College of Education, Ganwar, Sachivalaya City, Brahmanan, Dadia, Sanganer, Jaipur, Rajasthan for. STC Course on 09.06.2007.

AND WHEREAS, the recognition was granted to the institution, namely, Ujas College of Education Ganwar, Sachivalaya, City – Brahmanan, Dadia, Sanganer, Jaipur, Rajasthan for STC (D.El.Ed.) Course vide order No.- File No. File No. NRC/NCTE/RJ-1304/2008/59097-59103 Dt. 26.08.2008.


AND WHEREAS, the Northern Regional Committee, National Council for Teacher Education in its 275<sup>th</sup> (Part-1) Meeting held from 16<sup>th</sup> to 18<sup>th</sup> and 19<sup>th</sup> to 21<sup>st</sup> September, 2017 considered the case of the institution under provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. and decided as under:

- As per the letter of the Superintendent, First Office of the ACB, Jaipur, the institution has collected excessfees than prescribed by the State Govt.
- It has been found from the records, that land of the institution is on private lease in the name of an individual and not in favour of the institution or Society, which is against the then Regulations of NCTE.

Hence, show cause notice under Section 17 of the NCTE Act, 1993 be issued to the institution to submit reply within 30 days from the date of issue of show cause notice.

NOW THEREFORE, the institution is required to submit the representation /compliance accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations. The representation along with an affidavit must reach this office within 30 days of the issue of this notice. In case the office does not receive any representation within stipulated time, it will be presumed that the institution does not wish to make any representation, and the Northern Regional Committee shall take as per provisions of the NCTE Act, 1993 and regulations.

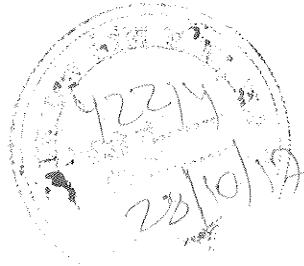
