In terms of section 14/15 of the NCTE Act, Shri Govind Swavittposhit Sansthan, Plot Number-1007-1008, Street/Road-Bilari Road, Village/Town/City-Bilari, Post Office-Kundarki, Tehsil/Taluka-Bilari, Town/City-Bilari, State-UP, District-Moradabad (UP), Pin Code-244413 had submitted an application to the Northern Regional Committee of NCTE seeking recognition/permission to the institution i.e Shri Govind Degree College, Plot Number-1007-1008, Street/Road-NA, Village/Town/City-Tewarkhas, Post Office-Kundarki, Tehsil/Taluka-Bilari, Town/City-Bilari, State-UP, District-Moradabad (UP), Pin Code-244413 for D.El.Ed Course on 07.07.2015.

The case of the institution was considered by NRC in its 275<sup>th</sup> Meeting (Part-1) and the Committee decided that show cause notice under section 14/15(3)(b) of the NCTE Act, 1993 be issued to the institution before refusal of recognition of the said course on the following points:


- The institution has not replied to the LOI issued on 28.06.2017 till date.

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Rules & Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
