In terms of section 14/15 of the NCTE Act, Aley Ahmed Educational Trust, Plot No.218, Street / Road - Bijnor Road, Village/Town/City - Amroha, Post Office - Amroha, Tehsil / Taluka - Amroha, Town/City - Amroha, District - Jyotibha Phule Nagar, State - Uttar Pradesh, Pin Code -244221 had submitted an application to the Northern Regional Committee of NCTE for grant of recognition for seeking recognition permission to the institution i.e Amani Group of institutions, Plot No. 218, Street / Road - Bijnor Road Road, Village/Town/City - Amroha Khas Bahar Chhungi, Post Office - Amroha, Tehsil / Taluka - Amroha, Town/City - Amroha, District - Jyotibha Phule Nagar, State - Uttar Pradesh, Pin Code -244221 for B.Ed Course on 02.06.2015.

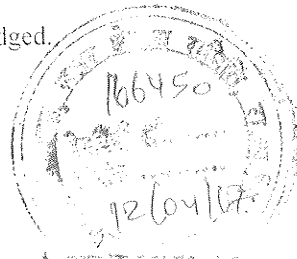
The case of the institution was considered by NRC in its 266th Meeting (Part-I-B) and the committee decided that show cause notice under section 14/15(3)(b) of the NCTE Act 1993 be issued to the institution before refusal the recognition of the said course on the following points:

- The institution has not submitted any proof / evidence to prove that it is a composite institution as per clause 2(b) of NCTE Regulations, 2014.
- The institution has not submitted the certified registered land documents issued by the Registering Authority or civil authority concerned in the name of the society/institution.
- The institution has not submitted the Non-Encumbrance certificate issued by the Competent Authority indicating that the land is free from all encumbrances.


In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.



In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14(3)(b)/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
