
The Northern Regional Committee, National Council for Teacher Education in its 217th meeting considered the case of your institution namely Ramesh Chand Jindal Degree College, Plot/Khasra Number-1338-1339, Street Number-Nil, Village-Naujheel, Post Office-Naujheel, Tehsil/Taluka-Mant, Town/City-Mathura, District-Mathura (UP), State-Uttar Pradesh, Pin Code-281203. for the proposed course B.Ed. along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs. The Northern Regional Committee after due deliberation and consideration of the case in detail and decided that application of the institution be summarily rejected on the following grounds:-

- As per land documents submitted by the institution the land is taken on lease basis from individual, which cannot be considered as per provision of clause 8 (7) (i) of NCTE Regulation, 2009, only Govt. land can be considered on lease basis.
- 2. In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days before summarily rejection on the above grounds.
- 3. Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under the provisions of NCTE ACT, 1993 Rules & NCTE Regulations as it deems fit and proper.
