This office is in receipt of Application No. NRCAPP 3894 dated 25/12/2012 for starting B.Ed course in J S Womens College of Education and Technology, Plot/Khasra Number-472, 473, 474, 477, Street Number- NA, Village- Dhoommanikpur, Post Office-Dhoommanikpur, Tehsil/Taluka- Dadri, Town/City- Dadri, District- Gautam Buddha Nagar (UP), State- Uttar Pradesh, Pin Code- 205207 for the session 2013-2014.

After scrutiny of the documents and other relevant materials furnished by you with your application, the case was placed before the NRC in its 216th meeting held on 27-28 June, 2013. The Committee decided as under -

"The original file of the Institution along with other related documents, NCTE Act, 1993. Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and the following deficiencies were observed in the application:-

1. The Society/institution has submitted lease deed between Mahavira Pupils Education Society and J S Women College of Education and Technology for a period of 30 years. As such private lease is not allowed under clause 8(7)(i) of the NCTE Regulations, 2009.

In view of the above position, NRC decided that a Show Cause Notice be issued to the Institution before summarily rejection of the application on the above grounds.

Before the Regional Committee passes an order of rejection on your application, you are hereby given an opportunity for making such written representation as you may wish to make.

Your written representation must reach this office within 30 days of the issue of this notice without fail. In case this office does not receive any representation within stipulated time, it will be Presumed that you do not wish to make any representation, and the Northern Regional Committee shall

take decision as it deems fit and proper.
