Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 214^h meeting held from 24^h to 25th April, 2013 considered the case of your institution namely B.R. College of Education, Dhani Ram Pura, Pehowa, District -Kurukshetra, Haryana for the proposed D.Ed. & B.Ed. Course alongwith original file of the institution, reply submitted by the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-HQrs. The NRC after considering the matter in detail observed/decided the following: -

The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time has been carefully considered by NRC and the Committee discussed and considered the case in detail and following observations were made:-

- The institution must submit original approval letter of the Competent Authority regarding building completion of B.R. College of Education.
- The application of the College of B.Ed. Programme (HR-821) shall not be entertained in view of the recommendation of the State Govt. vide memo no. 12/21-2013 C11(3) dated 11.02.2013 issued by the Deputy Director, College II Government of Haryana that further application for B.Ed. Colleges not to be entertained in Haryana.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 21 days from the date of issue of Show Cause Notice.

In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Regulations within 21 days.

Your written representation along with an affidavit must reach this office within 21 days of the issue of this notice. In the event of this office not receiving any representation within 21 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
