The Northern Regional Committee, National Council for Teacher Education in its 220<sup>th</sup> meeting considered the case of your institution namely SMT Chhavi Bind Shikshan Prashikshan Sanstha, Plot No. 83Kh, 88K, Khasara NO. 83Kh, 88K, Street Number- Reewa Road, Village/Town- Bhorsar, Post office-Amoi, Tehsil/Taluka- Sadar, Town/City- Mirzapur, State- UP, District- Mirzapur (UP), Pin Code – 231001, for the New Recognition in D.El.Ed. course along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs.
