Sub: Notice under Clause 7(1) of NCTE Regulation 2009 -- (Code No. NRCAPP 3093).

This office is in receipt of Application No. NRCAPP 3093 dated 19/12/2012 for starting B.Ed course in Saint JohnsAcademy Educational college, Plot/Khasara No. 54/61, Plot No. -0, Street Number-0, Vill-Chhitrai, Post Office- Mohammadabad, Teh/Taluk- Tundla, Town/City- Tundla, Dist- Firozabad, State-UP, Pin-283204

After scrutiny of the documents and other relevant materials furnished by you with your application, the case was placed before the NRC in its 214th meeting held on 24-25 April, 2013. The Committee decided as under -

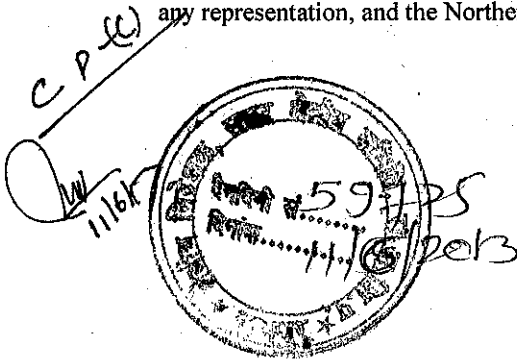
"The original file of the Institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and the following deficiencies were observed in the application:-


- The Society/Institution has submitted the application for B.Ed course for the academic session 2013-14. The online submission has been done on 17/12/12 and hard copy received in NRC on 19/12/2012.
- From scrutiny of the file, it has been observed that the Society/institution has submitted Private lease deed between Smt. Indu Sharma W/o Shri S.P. Sharma And Shri Mahatma Parmanad Siksha Prasar Samiti for a period of 29 years.
- As per clause 8(7)(i), No. institution shall be granted recognition under these Regulations unless the institution or society sponsoring the institution is in possession of required land on the date of the application. The land free from all encumbrances could be either on ownership basis or on lease from Government or Government institution for a period of not less than 30 years. In cases where under relevant state or Union Territory laws the maximum permissible lease period is less than 30 years, the State Government or Union Territory Administration law shall prevail. However, no building shall be taken on lease for running any teacher training course. Thus, the institution does not possess valid land on the date of application.

In view of the above position, NRC decided that a Show Cause Notice be issued to the Institution before summarily rejection of the application on the above grounds.."

Before the Regional Committee passes an order of rejection on your application, you are hereby given an opportunity for making such written representation as you may wish to make.

Your written representation must reach this office within 30 days of the issue of this notice without fail. In case this office does not receive any representation within stipulated time, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take decision as it deems fit and proper.
