The Northern Regional Committee, National Council for Teacher Education in its 220th meeting considered the case of your institution namely Dr Ram Monohar Lohia Institute, Plot No. 387 & 388, Khasara NO. 387 & 388, Street Number- 387 & 388, Village/Town- Sikri Kalan, Post office- Modinagar, Tehsil/Taluka- Modinagar, Town/City- Modinagar, State- UP, District- Ghaziabad (UP), Pin Code – 210204, for the Increase in Intake in B.Ed. course along with original file of the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines and guidelines issued by NCTE-HQrs.
