This has reference to the subject cited above, institution has submitted an application in online mode on 30.12.2012 and physical application has been received in the office of NRC on 04.01.2013 for D.El.Ed. course in the proposed institution i.e. City Girls College, Plot/Khasara No.- PS-2, Street Number- Ratan Khan, Village- Sharda Nagar, Post Office- Dilkusha, Tehsil/Taluka- Sadar, Town/City- Lucknow, District-Lucknow, Pin Code- 226002, State- Uttar Pradesh. The said application has been processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application is found deficient on the following points which are as under:-

Show Cause Notice before summarily rejection under clause 7(1) of NCTE Regulation, 2009-reg.

- As per land documents submitted by the institution the land is taken on lease basis from individual, which cannot be considered as per provision of clause 8 (7) (i) of NCTE Regulation, 2009. only Govt. land can be considered on lease basis.
- Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- 2. The matter was considered by NRC in its 214th Meeting and it was decided that a Show Cause Notice be issued to the Institution before summarily rejection of said application on the following grounds:
 - As per land documents submitted by the institution the land is taken on lease basis from individual, which cannot be considered as per provision of clause 8 (7) (i) of NCTE Regulation, 2009. only Govt. land can be considered on lease basis.

3. In view of the above, you are hereby requested to submit the representation of the institution on the above observation(s) within 30 days from the date of issue of notice.

4. Your written representation must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within stipulated period, it will be presumed that you do not wish to make any representation, and the NRC shall take the decision, as it deems fit and proper.
