Sub:- Notice under section 14 (3) (b) of the NCTE Act: Notice as per 221st NRC meeting decision.

Sir/Madam,

The society, Dr. Asha Educational Society, Plot No.1171, Street/Road- Dewa Road, Village/Town- Lucknow, Post office- Uptron, Tehsil/Taluka- Bakshi Ka Talab, Town/City- Lucknow, State- UP, District- Lucknow(UP), Pin Code -226019 has applied online on 24/12/2012 for grant of recognition to Dr Asha Smriti Mahavidyalaya, Plot No. 1171, Khasara NO. 1171, Street Number- Dewa Road, Village/Town- Goila, Post office-Uptron, Tehsil/Taluka- Bakshi Ka Talab, Town/City- Lucknow, State- UP, District- Lucknow(UP), Pin Code -226019 for B.P.Ed course for the academic session 2013-14.

As per decision of the NRC in its 220th meeting held from October 25th to 29th, 2013, Show Cause Notice was issued to the institution on 26/11/2013.

Further, the NRC in its 221st meeting held from November 15th to 17th, 2013 decided vide Agenda item no. 221.38.1. as under:

- "Processing of application the NRC prima facie observed that the some institutions have submitted more than one application, the name and address of these institutions are same. As per provisions of clause 8(2) of NCTE Regulation, 2009, in the first instance an institution shall be considered to grant of recognition of only one course for a basic unit as prescribed in the norms and standards for the particular teacher programme. Therefore, more than one application submitted by the institution cannot be considered at the same time. The names of such institutions are mentioned below. The NRC decided that Show Cause Notice under provision of clause 14/15 (3)(b) of NCTE Act, 1993 be issued to all these institutions on the ground that the institution has submitted more than one application which is against the provision of clause 8(2) of NCTE Regulations, 2009. The institutions be also directed to submit their options regarding which one of the application be considered by NRC. The NRC further decided that the decision concerning the applications of the following institutions already taken, if any be also kept in abeyance till reply of the show cause notice is received from the concerned institution and considered by the NRC."


As per office records, it has been noticed that the institution has also submitted another application (NRCAPP 7920) for grant of recognition/permission for D.El.Ed. course for the academic session 2013-14 on same address on which the present application has been submitted which is violation of clause 8(2) of the NCTE Regulations, 2009.

In view of the above, you are hereby requested to submit the written representation of the institution giving option regarding which of the applications is to be processed by the NRC, accompanied with an affidavit from the authorized representative of the management as per provisions of the NCTE Act, Regulations within 30 days.

Your written representation along with an affidavit must reach this office within 30 days of the issue of this notice. In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
