Sir/Madam,

The Northern Regional Committee, National Council for Teacher Education in its 220th meeting held from October 25th to 29th, 2013 considered the case of your institution namely Vindhya Kanya Post Graduate College Plot/Khasara No- 70, 19/0, 752, 194, 95, Vill- Urmaura, Post Office- Robertsganj, Tehsil- Robertsganj, Distt- Sonbhadra, Pin Code-231216, UP., for the New Recognition in B.Ed. course along with original file of the institution, reply submitted by the institution viz-a-viz provisions of the NCTE Act, Rules, Regulations and guidelines issued by NCTE-Hqrs. The NRC after considering the matter in detail observed/decided the following:-

The original file of the Institution and along with other related documents, NCTE Act, 1993, Regulations and Guidelines of NCTE published from time to time were carefully considered by NRC in detail and following observations was made:-

- Copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority submitted by the institution but not notarized.

Hence, NRC decided that Show Cause Notice under section 14/15 (3) (b) of NCTE Act, 1993 be issued to the Institution on the above point and direct the Institution to submit the reply as per the provisions of NCTE Act, 1993 Rules & Regulations within 30 days from the date of issue of Show Cause Notice.


In view of the above, you are hereby requested to submit the representation of the institution accompanied with an affidavit from the authorized representative of the management as per provision of the NCTE Act, Rules & Regulations within 30 days.



In the event of this office not receiving any representation within 30 days of the issue of this notice, it will be presumed that you do not wish to make any representation, and the Northern Regional Committee shall take the decision under Section 14/15(3)(b) of the NCTE Act, 1993 as it deems fit and proper.
