Withdrawal Order

WHEREAS, the recognition was granted by NRC to Springdale Mahila Mahavidyalaya, Dohna Pitamrai, Nainital Road, Bareilly- 243005, Near Siddhi Vinayak Institute of Technology, Uttar Pradesh for B.Ed. course vide order no. F. NRC/NCTE/F-3/UP-837/2003/3565-3573 dated 12.08.2003 with an annual intake of 100 seats from the academic session 2003-2004.

AND WHEREAS, a letter dated 17.02.2014 was received from Shri Arvind Patel, Chairman, Student Association, M.J.P. Rohilkhand University, Bareilly, Uttar Pradesh making complaint against the institution.

AND WHEREAS, the matter was considered by NRC in its Emergent meeting held on 10<sup>th</sup> to 11<sup>th</sup> June, 2014 and the Committee considered the letter received from Shri Arvind Patel, Chairman, Student Association, M.J.P. Rohilkhand University, Bareilly, Uttar Pradesh for non-compliance of NCTE norms and decided that Show Cause Notice under Section 17 of NCTE Act, 1993 be issued to the institution before withdrawal of recognition on grounds mentioned in the letter. The copy of the letter be forwarded to the institution. Accordingly, Show Cause Notice dated 23.06.14 was issued to the institution under Section 17 of NCTE Act, 1993.

AND WHEREAS, the institution did not submit reply of Show Cause Notice dated 23.06.2014. The matter was considered by NRC in its 261<sup>st</sup> Meeting held on 14<sup>th</sup> to 19<sup>th</sup> December, 2016. The Committee observed that "the applicant institution has not submitted the reply of the show cause notice of the NRC, NCTE issued under Section 17 of the NCTE Act, 1993. The Committee, therefore, decided to withdraw the recognition of the institution for B.Ed. course under Section 17 of the NCTE Act, 1993".

NOW, THEREFORE, in exercise of the powers vested under section 17(1) of NCTE Act, 1993, the Northern Regional Committee hereby withdraws the recognition granted to Springdale Mahila Mahavidyalaya, Dohna Pitamrai, Nainital Road, Bareilly- 243005, Near Siddhi Vinayak Institute of Technology, Uttar Pradesh for B.Ed. course on the grounds mentioned above from the end of the academic session next following the date of order of withdrawal.

If the institution is not satisfied by the above order, they can prefer an appeal to the Council (NCTE, New Delhi) in terms of section 18 of NCTE Act, 1993 within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE Website
