This has reference to the subject cited above, institution has submitted an application in online mode on 19.09.2011 and physical application has been received in the office of NRC on 07.10.2011 for D.EL.ED. course in the proposed institution i.e. Vimla Vikram Mhavidyalaya, Plot No.-666, 607, 608, Street No.-0, Village – Pachrewala, Post Office- Balrampur, Tehsil/Taluka- Balrampur, Town/City-Balrampur, District-Lucknow, Pin Code-271206, UP. The said application was processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application was found deficient on the following points which are as under:-

- The recognition for B.Ed. course was granted by NRC on 02.02.2010, hence a certificate from the concerned university is required that the three academic session has been completed as on 01.08.2011.
 - Certified copy of registered land documents issued by the competent authority (office of Registrar/Sub Registrar) as required under provision of NCTE Regulations, 2009 has not submitted.
 - The institution has submitted approved building plan approved by Gram Pradhan but plot/khasra no and name of proposed course are not mentioned on the building plan.
 - The institution is also running B.Ed. course hence, the building plan should be clearly demarcated area for both course.
- Notarized copy of change of land use certificate issued under clause 143 of UP land Act by the competent authority has not submitted.
- The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hence the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

The above deficiencies were communicated to your Institution by NRC vide letter No. F.No.NRCAPP-2391/D.El.Ed./UP/DLI/2012-13/17347 dated 20.03.2012. The institution has not submit the reply of deficiency letter and the matter was considered by NRC in its 205th Meeting and as per decision taken by NRC, the Rejection Letter dated 17.10.2012 was issued to institution. The institution preferred an appeal dated 01.03.2013 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the aforesaid order. In compliance of the order passed by the Appellate Authority (NCTE New Delhi), the matter was considered by NRC in its 213th Meeting and it was decided that deficiency letter may be issued again to the Institution.

2. In terms of above decision, the above deficiencies are hereby again communicated to you with advise to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.


3. In addition to above, the institution is also requested to submitted original file FDRs of 5 lakhs & 3 lakhs which were return to the institution earlier.

4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
