Sir/Madam,

This has reference to the subject cited above, institution has submitted an application in online mode on 26.09.2011 and physical application has been received in the office of NRC on 30.09.2011 for D.El.Ed. course in the proposed institution i.e. Urmil Ichha Mahavidyalaya, Plot No.:- 31, Street Road:-0,Village:- Dhaurahara Kuti Nansa Bazar, Post Office – Chandrikaganj, Tehsil/Taluka:- Bikapur, Town/city:- Faizabad, District:- Faizabad, Pin Code:-224141, State: Uttar Pradesh. The said application was processed by the NRC, NCTE as per provisions contained in the NCTE Regulation 2009. It is informed that on preliminary perusal of the documents submitted with your application viz a viz provisions of the NCTE Regulation, 2009, your application was found deficient on the following points which are as under:-

- The institution has submitted approved building plan approved by Gram Pradhan but name of the proposed course is not mention on the building plan.
- Date of registration of land document is not mention in the affidavit.
- The specific information of land/ building, demarcated area as required in clause 8(7)(ii) and information required under clause 8(2) 8(3) of NCTE Regulations 2009 and information related to resolution of the society for opening the said course not for profit etc has not given by the institution hence the same is required from the institution in the affidavit(format of the affidavit is enclosed herewith).

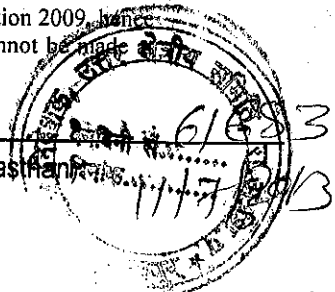
The above deficiencies were communicated to your Institution by NRC vide letter No. F. No. NRCAPP-2034/D.El.Ed./UP/DLI/2012-13/16243 dated 24.02.2012 and the matter was considered by NRC in its 203rd Meeting and as per decision taken by NRC, the application of the institution was Rejected vide latter dated 11.01.2013. The institution preferred an appeal dated 30.04.2013 to the NCTE, New Delhi under Section 18 of the NCTE Act, 1993 against the aforesaid order. In compliance of the order passed by the Appellate Authority (NCTE New Delhi), the matter was considered by NRC in its 215th Meeting and it was decided that deficiency letter may be issued again to the Institution.

2. In terms of above decision, the above deficiencies are hereby again communicated to you with advise to remove/make good of the above deficiencies within a period of 60 days failing which your application will be treated as rejected and closed. It may be noted by the institution it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. In addition to above, the institution is also requested to submitted original file FDRs of 5 lakhs & 3 lakhs which were return to the institution earlier.


4. Your reply/representation along with all necessary documents accompanied with an Affidavit in support of the reply of the above points must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Rules & Regulations.

5. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
