The Society/Trust has submitted an application through online mode on 31/12/2012 and physical application has been received in the office of NRC on 07/01/2013 for B.Ed. course in the proposed institution, by Great Ganges Institute of Technology, Plot No.326Kh, 327, 327M, Khasara No. 326Kh, 327, 327M, Street Number- Gadankhera, Village/Town- Gadankhera, Post office- Singrausi, Tehsil/Taluka- Unnao, Town/City- Unnao, State- UP, District- Unnao (UP), Pin Code -209801. The said application has been processed by the NRC, NCTE as per contained in the NCTE Regulations, 2009 and amendments made thereto from time to time. It is informed that on preliminary perusal of the documents submitted with your application viz-a-viz provisions of the NCTE Regulations, 2009, your application is found deficient on the following points which are as under:-

- CLU submitted is not originally notarized. Originally notarized, change of land use (CLU) certificate issued by SDM under Section 143 of the U.P. Land Act is to be submitted.
- Plot/khasara nos. given in the CLU certificate does not match with the Land document and application.
- Building Plan submitted is not approved by the competent authority/Local body.
- Total land area and built-up area given in the building plan does not match with the application.
- Plot/Khasara nos. given in the building plan are 326ख and 327, whereas in the application Plot/Khasara no.326ख, 327मि and 327 are mentioned.
- The address of the institution given in the FDRs does not match with the application.
- The institution is also running PGDM, MBA and Public School courses. Clarification be given whether these course are running in the same building in which this application has been made or at a different location. If at a different location, complete address details be given.
- No CLU certificate has been submitted in r/o plot nos. 327 and 326ख.
- The institution is also required to submit on Affidavit on Rs 100/- Stamp Paper as per format enclosed in support of information required as per clause 8(2), 8(3) and 8(7) (2) of the NCTE Regulations, 2009 and Page-2, 4 and 5 of the online Application form.

2. You are advised to remove/make good the above deficiencies within a period of 60 days. It may be noted by the institution that it is the sole responsibility of the institution to ensure proper compliance of all the essential documents as per provisions of the NCTE Act, Rules & Regulations.

3. Your reply/representation alongwith all necessary documents must be submitted within 60 days of issue of this letter, failing which appropriate action will be taken as per provisions of the NCTE Act, Rules & Regulations.

4. Reply in piece meal will not be accepted. Since application has been processed as per clause 6 of the NCTE Regulation 2009, hence once the application is duly processed by this office, the claim for refund of application/processing fee cannot be made at any stage of application, whatsoever be the case.
