Subject: Clarification regarding requirement of qualifications for Teaching faculty for B.Ed. course appointed prior to Regulation, 2014

Sir,

I am directed to refer to your letter No. NRC/NCTE/Acad./2016-2017/150987 dated 14th June, 2016 regarding the subject mentioned above. You have sought for clarification on the following points :-

1. Now, will the lecturers possessing 50% marks and above but below 55% marks in Master's degree in any school subject (Science/Humanities/Arts etc.) and M.Ed./M.A. in education with 55% marks have been working as Lectures in B.Ed. college since prior to the enforcement of NCTE Regulation, 2014?
2. Will they be exempted from the stipulated prescribed qualifications (Percentage of marks) mentioned in the NCTE Regulations (Recognition, Norms and Procedure) 2014 ?
3. Or the old such teaching staffs who have been working as lecturers in B.Ed. College since prior to the NCTE Regulation, 2014 came into enforcement, will they have to be at par of new, NCTE Regulation, 2014?

In all the above three points, it is clarified that the teaching faculty appointed by the concerned teacher education institutions prior to the notification of the NCTE Regulation, 2014 on the basis of the existing Regulations notified time to time shall be allowed to continue with an advice to advise them to upgrade their qualifications as per the NCTE Regulation, 2014.
